

## **Santa in the Park 2018 - Terms and conditions**



### **1. General**

These booking terms and conditions apply to everyone who takes part in any activities held as part of the 'Santa in the Park event 2018'. Terms and conditions also apply to spectators accompanying participants.

These terms and conditions contain important information regarding participation, and upon entry you agree to and accept these terms and conditions.

- a. Photography and drone aerial filming will be taking place during the day, and specifically during the Guinness World Records Record Attempt. This will include taking photographs of participants throughout various activities. Photographs taken will be used on promotional materials by St Wilfrid's Hospice. By taking part in activities you are agreeing to potentially being filmed or photographed.
- b. There is limited parking immediately near Priory Park. We recommend people walk, take public transport or use nearby car parks. The closest large car park is Northgate Carpark.
- c. If necessary, potential participants should gain advice from your GP as to whether you are physically prepared to undertake the challenges you sign up to do.
- d. There are specific rules for taking part in the Guinness World Records Record Attempt – please see **section 9** for these rules before buying a ticket.

### **2. Booking process, prices and payment**

- a. The fees for all activities are non-refundable and non-transferable unless this event is cancelled.
- b. All people under the age of 18 qualify for a Child's ticket.
- c. Booking for all activities can be done via the St Wilfrid's Hospice (Chichester) website
- d. Booking on the day is available for all activities but there may be limited spaces available on the day. Booking in advance is strongly advised.

### **3. Safety and age restrictions**

- a. Children under the age of 16 must be accompanied by an adult at the event.
- b. For the Guinness World Record Attempt please note that any participant under the age of 18 will need a parent or guardian to sign them into the registration desk on their behalf. The parent/guardian who signs, does not need to take part in the event.

- c. Children under the age of 5 are free to take part in the Santa Streetdance and must be accompanied by a parent/guardian who is responsible for their safety. There will be spacious areas for anyone with a child under the age of 5 taking part.
- d. Children under the age of 5 will not be permitted to play in Santa's snowball games for their own safety.
- e. All safety barriers are to be respected at this event by all participants and all spectators attending.
- f. People with disabilities are very welcome to take part in all activities. Due to the nature of the event, the location and some uneven terrain through the grounds. There are accessible paths all around the park and entry to the park. Please contact the Hospice prior to booking to discuss access to all the activities on the day and discuss access needs.
- g. Dogs are not permitted into Priory Park at any time.
- e. Priory Park is a no smoking environment.
- f. Nobody is allowed access onto the cordoned off area around the cricket ground during the event due to the drone flying that will take place from this position in the park.

#### **4. Clothing**

- a. St Wilfrid's Hospice will provide a Santa hat to those taking part in the Santa Street Dance who have purchased an adult or a child ticket. Infants are free and will not receive a Santa hat, but Reindeer antlers will be available for a small donation if desired.
- b. Please ensure you wear something comfortable to take part, and bring suitable waterproofs should there be bad weather.
- c. Suitable shoes to wear on grass are essential.
- d. The Santa Streetdance will be performed outside with no weather protection - please dress appropriately for the weather on the day.

#### **5. Changes to the event**

- a. It may be necessary for reasons beyond our control to change the content and timing of the event, the date or the venue at any time prior to the event date.

#### **6. Cancellation**

- a. St Wilfrid's Hospice accepts no liability if the event is cancelled or postponed for reasons beyond our reasonable control resulting from an act of God, governmental regulation, fire, war, terrorist activity or civil commotion.
- b. St Wilfrid's Hospice reserves the right to cancel this event at any time. In the event of this happening all participants will be emailed to inform them of why and what the refund process will be.

#### **7. Data protection**

- a. We will not sell or share your details with other charities or organisations (in compliance with the Data Protection Act 1998)

## 9. Guinness World Record Attempt (GWR)

**These terms and conditions are specifically for participants taking part in St Wilfrid's Hospice official Guinness World Records Record Attempt for the 'largest streetdance lesson' which will happen in Priory Park, 16<sup>th</sup> December 2018.**

- a. To complete the official Guinness World Records Record Attempt for the 'largest streetdance lesson' there will be a small introduction of what you will be taking part in, a 30 minute lesson followed by a final 3 minute dance. The whole session will be lead by one teacher with several assistants to ensure everyone can see how the dance moves are performed. The lesson is designed to be accessible, performed by everyone of all ages and abilities.
- b. There will be an official start time and end signalled by a loud noise.
- c. Those taking part will be asked to sign in at the registration desk and this will be used as part of the evidence for how many people took part in the record attempt.
- d. By taking part in this event you agree to us sharing your name with Guinness World Records as part of our evidence to secure the record.
- e. Those under the age of 18 must have a parent or guardian who must sign on behalf of them to the registration desk on the day as official permission to take part.
- f. In order to take part in the record attempt you must purchase a ticket, and register officially on the day with St Wilfrid's Hospice.
- g. Filming - All attendees for the Guinness World Records Record Attempt will have to go through a 'Clicker' gate process to ensure that the count for number of people entering into the record is accurate. This will be filmed as part of the evidence for the GWR attempt. By agreeing to take part in the record attempt you agree to be filmed at the clicker gate and during the full record attempt.
- h. Entry into the area for the official record attempt will be strictly controlled. You agree to follow guidance and signage so that you can be correctly counted in.
- i. All people must be making a genuine attempt to follow the lesson and perform the dance at the end of the lesson. **People are allowed to leave the record attempt but will be discounted from the final number of people counted.**
- j. There will be stewards watching the crowd to judge 'participation' in the event – those people not fully participating in the event during the record attempt will not be counted in the final count, but are very welcome to stay inside the area whilst the record happens.
- k. All attendees will be split into groups of 50 so counting and participation are easily performed by the official stewards. Please ensure you enter the clicker gate with anyone else you would like to take part with.
